**AN ORDINANCE ADDING SECTION 5.20.300 TO THE CITY OF COLUMBIA  
LIQUOR CODE AND AMENDING SECTION 18.95.006 OF THE CITY OF  
COLUMBIA, ILLINOIS MUNICIPAL CODE TO AMEND THE FEES TO BE  
ASSESSED FOR THE ANNUAL CATERER'S LIQUOR LICENSES IN THE CITY**

**WHEREAS**, the City Council of the City of Columbia, Illinois previously adopted Chapter 5.20 ("Liquor Code") to be included in the City's Municipal Code; and

**WHEREAS**, the City has determined that it needs to add a section to its liquor code which would allow establishments that hold a valid Class "A-1", "A-2", and "B" License to also hold a caterer's license (Class "E"); and

**WHEREAS**, the City Council of the City of Columbia, Illinois now desires to amend its liquor code by adding Section 5.20.300; and

**WHEREAS**, the City Council of the City of Columbia, Illinois ("City") has previously found, determined, and declared that it was necessary and appropriate for the City Council to amend TITLE 18 of the City's Municipal Code, entitled:

**"FEES AND CHARGES TO BE ASSESSED FOR CITY SERVICES AND  
BUSINESS LICENSE FEES TO BE ASSESSED FOR THE CONDUCT AND  
OPERATION OF BUSINESSES, OCCUPATIONS, AND PROFESSIONS IN THE  
CITY"**

to change some of the fees and charges the City will collect effective upon the passage of this ordinance as provided by law, and to continue in effect after the enactment of the ordinance until said TITLE 18 of the City's Municipal Code is again amended by enactment of a City Ordinance changing said City's fees and charges; and

**WHEREAS**, the City Council of the City of Columbia, Illinois now desires to amend Section 18.95.006 of the City's Municipal Code to include fees to be assessed for the annual caterer's liquor licenses in the City.

**NOW, THEREFORE, BE IT ORDAINED**, by the City Council of the City of Columbia, Illinois, as follows:

**Section 1.** That the preceding recitations in the upper part of this Ordinance are realleged, restated and adopted as paragraph one ("1") of this Ordinance.

**Section 2.** That Section 5.20.300 of the City Liquor Code shall be added and will read as follows:

## Section 5.20.300

No location, establishment or premises shall be issued more than one (1) liquor license for such location, establishment or premises at any given time. However, a location, establishment or premises may be issued a caterer's license (Class "E") if it holds a valid Class "A-1", "A-2", or "B" license.

**Section 3.** That Section 18.95.006 of the City Code, pertaining to annual liquor license fees for "Caterer's License" shall be deleted in its entirety, and the following inserted in its place:

18.95.006	Class E – Caterer, on/off premises	
	Caterer's License Only	600.00
	Caterer's License with A-1, A-2, or B License	75.00

**Section 4.** This Ordinance shall be in full force and effect immediately upon passage as provided by law.




