

ORDINANCE NO. 3456

AN ORDINANCE TO AUTHORIZE A JOINT AGREEMENT BETWEEN THE ILLINOIS DEPARTMENT OF TRANSPORTATION AND THE CITY OF COLUMBIA, ILLINOIS WITH REGARD TO THE MAIN STREET STREETSCAPE, PHASE 2 AND 3 AND THE SOUTH MAIN STREET RESURFACING PROJECT IN THE CITY OF COLUMBIA, ILLINOIS.

WHEREAS, the City of Columbia, Illinois (the "City") has had completed the engineering design and it is necessary and appropriate and now time for the City to enter into a joint agreement with the Illinois Department of Transportation ("IDOT") for the Main Street Streetscape, Phase 2 and 3, and the South Main Resurfacing Project.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

Section 2. The joint agreement between the City and IDOT for the Main Street Streetscape, Phase 2 and 3, and the South Main Street Resurfacing Project, a copy of which is attached hereto, is hereby approved to form and the Mayor is hereby authorized and directed to make and enter into the agreement for and on behalf of the City, in as many counterparts as the Mayor shall determine; and, the City Clerk is hereby authorized and directed to attest the same and affix thereto the corporate seal of the City.

Section 3. This Ordinance shall be in full force and effect, from and after its passage, as provided by law.
