**AN ORDINANCE TO AMEND ORDINANCE NO. 2745 WHICH PROVIDED FOR  
THE APPOINTMENT OF MEMBERS OF CERTAIN BOARDS, COMMISSIONS  
AND COMMITTEES OF THE CITY OF COLUMBIA, ILLINOIS FOR THE  
FISCAL YEAR OF THE CITY COMMENCING MAY 1, 2009 AND ENDING  
APRIL 30, 2010**

WHEREAS, The City Council of the City of Columbia, Illinois adopted Ordinance No. 2745 on September 21, 2009, and now finds it necessary to amend said ordinance to fill a vacancy on (A) the Columbia Zoning Board of Appeals; and (B) the Columbia Plan Commission by appointing a new member to each of those respective bodies.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois as follows:

**Section 1.** Ordinance No. 2745, Section 1, Columbia Zoning Board of Appeals, is hereby amended by deleting the words, "Chris Hargan (for the unexpired term of John N. Kirk) – 09/21/09 – 04/30/11", and adding the words, "Chris Webster – 11/02/09 – 04/30/11" in its stead.

**Section 2.** The following person is hereby appointed to serve the unexpired term of Chris Hargan (for the unexpired term of John N. Kirk) as a member of the Columbia Zoning Board of Appeals, for the following term, to wit:

**Section 3.** Ordinance No. 2745, Section 2, Columbia Plan Commission, is hereby amended by deleting the words "Gary Shondy – 05/01/09 – 04/30/12", and adding the words, "Dwayne Worley – 11/02/09 – 04/30/12" in its stead.

**Section 4.** The following person is hereby appointed to serve the unexpired term of Gary Shondy as a member of the Columbia Plan Commission, for the following term, to wit:

Dwayne Worley	11/02/09 – 04/30/12

**Section 5.** All other appointments made by, and provisions contained in, said Ordinance No. 2745 not amended hereby, shall remain in full force and effect.

**Section 6.** This ordinance shall be in full force and effect, and the appointments made herein shall be effective as of the appointment dates shown hereon, from and after its passage as provided by law.
