

**CITY OF COLUMBIA, ILLINOIS**  
**ORDINANCE NO. 3631**

**AN ORDINANCE LEVYING THE TAXES FOR THE  
FISCAL YEAR ENDING APRIL 30, 2023**

An ordinance providing for and the making of the tax levy for the twelve months beginning May 1, 2022 and ending April 30, 2023 for the uses and purposes hereinafter set forth for the City of Columbia ("City") in the State of Illinois after adoption of Ordinance No. 3609 on April 18, 2022, which ordinance established the City's Budget for its fiscal year commencing May 1, 2022 and ending April 30, 2023 ("City's Budget Ordinance").

**WHEREAS**, the City Council of the City of Columbia, Illinois has determined that it is necessary to raise the sum of \$3,019,839 for the purposes set forth below:

**Section 1.** That there be and is hereby levied upon all the taxable property within the corporate limits of said City of Columbia, Illinois, as the same is assessed and equalized for State and County taxation for the City's fiscal year ending April 30, 2023 the sum of THREE MILLION NINETEEN THOUSAND EIGHT HUNDRED THIRTY-NINE DOLLARS AND NO CENTS (\$3,019,839.00) for the following specific purposes, as reflected in the City's Budget Ordinance, and in the respective sums as follows:

**Section 2.** The Special Library Building Levy in the amount of \$51,904 shown immediately above is being levied pursuant to 75 ILCS 5/3-1 and City Resolution No. 2022-26, approved on October 3, 2022, providing for the levying of a tax not to exceed 0.02% of the value of all the taxable property in the City, as equalized or assessed by the Illinois Department of Revenue, with the proceeds of such tax to be restricted in use to the purchase of sites and buildings, for the construction and equipment of buildings, for the rental of buildings required for library purposes, and for maintenance, repairs and alterations of library buildings and equipment.

**Section 3.** The City Clerk of the City of Columbia is hereby authorized and directed to promptly file a properly certified copy of this tax levy ordinance with the County Clerks of Monroe County and St. Clair County, Illinois.

**Section 4.** This ordinance shall take effect and be in force from and after its legal passage and approval, and shall be numbered and known as Ordinance No. 3631 of the City of Columbia, Illinois.

**PASSED** by the City Council and **APPROVED** by the Mayor of the City of Columbia, Illinois and deposited and filed in the office of the City Clerk on the 5<sup>th</sup> day of December 2022, the vote being taken by ayes and noes and entered upon the legislative record as follows:




