ORDINANCE NO. 3655

**AN ORDINANCE LEVYING THE TAXES FOR THE
FISCAL YEAR ENDING APRIL 30, 2024**

An ordinance providing for and the making of the tax levy for the twelve months beginning May 1, 2023 and ending April 30, 2024 for the uses and purposes hereinafter set forth for the City of Columbia, Counties of Monroe and St. Clair, Illinois after adoption of Ordinance No. 3641 on April 24, 2023, which ordinance established the City's Budget for its fiscal year commencing May 1, 2023 and ending April 30, 2024 ("City's Budget Ordinance").

WHEREAS, the Corporate Authorities of the City of Columbia, Illinois have determined it is necessary to raise the sum of Three Million One Hundred Seventy-Four Thousand Two Hundred Eighteen Dollars (\$3,174,218) for the purposes set forth below.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Columbia, Illinois as follows:

Section 1. That there is hereby levied a tax upon all taxable property in the City of Columbia, Counties of Monroe and St. Clair, Illinois, the sum of One Million One Hundred Twenty-One Thousand Seven Hundred Sixty-Five Dollars (\$1,121,765), said amount shall be raised by taxation upon said property according to its valuation as the same is assessed for State and County purposes for the current year, which said amount is levied to defray the necessary expenses and liabilities of said City as provided by the Annual Budget Ordinance for the fiscal year of said City, beginning on the 1st day of May, 2023 and ending on the 30th day of April, 2024 and the said levy shall be as follows:

Total Amount of Section 1 to be raised by Levy for CORPORATE PURPOSES: \$1,121,765

Section 2. That in addition to the foregoing items in Section 1 hereof, there is hereby levied a tax upon all taxable property in the City of Columbia, Counties of Monroe and St. Clair, Illinois, the sum of One Hundred Forty-Three Thousand Three Hundred Nine Dollars (\$143,309), said amount shall be raised by taxation upon said property according to its valuation as the same is assessed for State and County purposes for the current year, which said amount is levied to defray the necessary expenses and liabilities of said City as provided by the Annual Budget Ordinance for the fiscal year of said City, beginning on the 1st day of May, 2023 and ending on the 30th day of April, 2024 and the said levy shall be as follows:

Total Amount of Section 2 to be raised by Levy for IMRF: \$143,309

Section 3. That in addition to the foregoing items in Section 1 and 2 hereof, there is hereby levied a tax upon all taxable property in the City of Columbia, Counties of Monroe and St. Clair, Illinois, the sum of Five Hundred Sixty-Three Thousand Six Hundred Twenty-Six Dollars (\$563,626), said amount shall be raised by taxation upon said property according to its valuation as the same is assessed for State and County purposes for the current year, which said amount is levied to defray the necessary expenses and liabilities of said City as provided by the Annual

Budget Ordinance for the fiscal year of said City, beginning on the 1st day of May, 2023 and ending on the 30th day of April, 2024 and the said levy shall be as follows:

Total Amount of Section 3 to be raised by Levy for POLICE PENSION: \$563,626

Section 4. That in addition to the foregoing items in Section 1-3 hereof, there is hereby levied a tax upon all taxable property in the City of Columbia, Counties of Monroe and St. Clair, Illinois, the sum of Four Hundred Forty-Five Thousand Four Hundred Twenty-One Dollars (\$445,421), said amount shall be raised by taxation upon said property according to its valuation as the same is assessed for State and County purposes for the current year, which said amount is levied to defray the necessary expenses and liabilities of said City as provided by the Annual Budget Ordinance for the fiscal year of said City, beginning on the 1st day of May, 2023 and ending on the 30th day of April, 2024 and the said levy shall be as follows:

Total Amount of Section 4 to be raised by Levy for LIBRARY: \$445,421

Section 5. That in addition to the foregoing items in Section 1-4 hereof, there is hereby levied a tax upon all taxable property in the City of Columbia, Counties of Monroe and St. Clair, Illinois, the sum of One Hundred Seven Thousand Nine Hundred Sixty-Eight Dollars (\$107,968), said amount shall be raised by taxation upon said property according to its valuation as the same is assessed for State and County purposes for the current year, which said amount is levied to defray the necessary expenses and liabilities of said City as provided by the Annual Budget Ordinance for the fiscal year of said City, beginning on the 1st day of May, 2023 and ending on the 30th day of April, 2024 and the said levy shall be as follows:

Total Amount of Section 5 to be raised by Levy for REFUSE COLLECTION: \$107,968

Section 6. That in addition to the foregoing items in Section 1-5 hereof, there is hereby levied a tax upon all taxable property in the City of Columbia, Counties of Monroe and St. Clair, Illinois, the sum of One Hundred Forty-Three Thousand One Hundred Fifty-Two Dollars (\$143,152), said amount shall be raised by taxation upon said property according to its valuation as the same is assessed for State and County purposes for the current year, which said amount is levied to defray the necessary expenses and liabilities of said City as provided by the Annual Budget Ordinance for the fiscal year of said City, beginning on the 1st day of May, 2023 and ending on the 30th day of April, 2024 and the said levy shall be as follows:

Total Amount of Section 6 to be raised by Levy for TORT & LIABILITY/PROPERTY INSURANCE: \$143,152

Section 7. That in addition to the foregoing items in Section 1-6 hereof, there is hereby levied a tax upon all taxable property in the City of Columbia, Counties of Monroe and St. Clair, Illinois, the sum of Three Hundred Nine Thousand Two Hundred Sixty-Six Dollars (\$309,266), said amount shall be raised by taxation upon said property according to its valuation as the same is assessed for State and County purposes for the current year, which said amount is levied to defray the necessary expenses and liabilities of said City as provided by the Annual Budget Ordinance for the fiscal year of said City, beginning on the 1st day of May, 2023 and ending on the 30th day of April, 2024 and the said levy shall be as follows:

Total Amount of Section 7 to be raised by Levy for STREET AND BRIDGE: \$309,266

Section 8. That in addition to the foregoing items in Section 1-7 hereof, there is hereby levied a tax upon all taxable property in the City of Columbia, Counties of Monroe and St. Clair, Illinois, the sum of Two Hundred Thirty Thousand Six Hundred Thirty-Two Dollars (\$230,632), said amount shall be raised by taxation upon said property according to its valuation as the same is assessed for State and County purposes for the current year, which said amount is levied to defray the necessary expenses and liabilities of said City as provided by the Annual Budget Ordinance for the fiscal year of said City, beginning on the 1st day of May, 2023 and ending on the 30th day of April, 2024 and the said levy shall be as follows:

Total Amount of Section 8 to be raised by Levy for SOCIAL SECURITY: \$230,632

Section 9. That in addition to the foregoing items in Section 1-8 hereof, there is hereby levied a tax upon all taxable property in the City of Columbia, Counties of Monroe and St. Clair, Illinois, the sum of Fifty-Four Thousand Four Hundred Sixty-Five Dollars (\$54,465), said amount shall be raised by taxation upon said property according to its valuation as the same is assessed for State and County purposes for the current year, which said amount is levied to defray the necessary expenses and liabilities of said City as provided by the Annual Budget Ordinance for the fiscal year of said City, beginning on the 1st day of May, 2023 and ending on the 30th day of April, 2024 and the said levy shall be as follows:

Total Amount of Section 9 to be raised by Levy for MEDICARE: \$54,465

Section 10. That in addition to the foregoing items in Section 1-9 hereof, there is hereby levied a tax upon all taxable property in the City of Columbia, Counties of Monroe and St. Clair, Illinois, the sum of Fifty-Four Thousand Six Hundred Fourteen Dollars (\$54,614), said amount shall be raised by taxation upon said property according to its valuation as the same is assessed for State and County purposes for the current year, which said amount is levied to defray the necessary expenses and liabilities of said City as provided by the Annual Budget Ordinance for the fiscal year of said City, beginning on the 1st day of May, 2023 and ending on the 30th day of April, 2024 and the said levy shall be as follows:

Total Amount of Section 10 to be raised by Levy for LIBRARY BUILDING & EQUIPMENT: \$54,614

Section 11. The Special Library Building Levy in the amount of \$54,614 shown immediately above is being levied pursuant to 75 ILCS 5/3-1 and City Resolution No. 2023-23, approved on October 2, 2023, providing for the levying of a tax not to exceed 0.02% of the value of all the taxable property in the City, as equalized or assessed by the Illinois Department of Revenue, with the proceeds of such tax to be restricted in use to the purchase of sites and buildings, for the construction and equipment of buildings, for the rental of buildings required for library purposes, and for maintenance, repairs and alterations of library buildings and equipment.

Section 12. The City Clerk of the City of Columbia is hereby authorized and directed to promptly file a properly certified copy of this tax levy ordinance with the County Clerks of Monroe County and St. Clair County, Illinois.

Section 13. This ordinance shall take effect and be in force from and after its legal passage and approval, and shall be numbered and known as Ordinance No. 3655 of the City of Columbia, Illinois.

PASSED by the City Council and **APPROVED** by the Mayor of the City of Columbia, Illinois and deposited and filed in the office of the City Clerk on the 4th day of December, 2023, the vote being taken by ayes and noes and entered upon the legislative record as follows:
