

CITY OF COLUMBIA, ILLINOIS
ORDINANCE NO. 3660

**AN ORDINANCE AMENDING THE PUBLIC HEARING DATE FOR THE
ESTABLISHMENT OF A BUSINESS DISTRICT IN THE CITY OF COLUMBIA**

WHEREAS, the City of Columbia, Monroe and St. Clair Counties, Illinois (the “City”) has the authority to designate an area as a Business District pursuant to the Business District Development and Redevelopment Law, constituting Section 65 ILCS 5/11-74.3-1, et seq., as amended (the “Law”), to share business district sales tax revenues generated by a redevelopment project in the proposed Business District to induce a developer’s undertaking and performance of such project; and

WHEREAS, it is essential to the City’s economic and social welfare that its business districts be developed, maintained, and/or revitalized by assuring opportunities for development and attracting sound and stable commercial growth; and

WHEREAS, the City contracted with PGAV Planners, LLC to create a business district plan for the Route 3/I-255 Business District; Business District Plan (the “Plan”) dated December 15, 2023 (attached hereto and incorporated by reference as Exhibit “A”), providing for development of the proposed Business District, and said Plan contains the Basis for Finding that the Business District is a Blighted Area under the Law; and

WHEREAS, the Law requires that the City set, by ordinance, the time and place for a public hearing on the proposal to approve a business district plan and designate a business district; and

WHEREAS, on December 4, 2023, the Corporate Authorities of the City passed and approved Ordinance No. 3659, setting the time and date of said public hearing; and

WHEREAS, the Corporate Authorities now find it necessary to reschedule said public hearing.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and City Council of the City of Columbia, Monroe and St. Clair Counties, Illinois, as follows:

Section 1. The preceding recitations in the upper part of this Ordinance are realleged, restated and adopted as paragraph one (1) of this Ordinance; and

Section 2. The public hearing to be held before the City Council on January 16, 2024, beginning at 6:45 p.m., at the City Hall is hereby canceled.

Section 3. The public hearing shall be held before the City Council on February 5, 2024, beginning at 7:00 p.m., at the City Hall.

Section 4. The Mayor, City Clerk, and City Attorney are hereby authorized to publish notice of the public hearing (attached hereto as Exhibit “B”) as required under the Act.

Section 5. This Ordinance shall become effective immediately upon its passage.
