WHEREAS, in the City of Columbia, Illinois ("City") the City Administrator is the City's Budget Officer ("Budget Officer"), and by State law it is the responsibility of the Budget Officer to complete the City's annual Budget and have it approved and adopted by the City Council and thereafter, among other things, it is the responsibility of the Budget Officer to establish and maintain procedures to insure that no expenditures are made by the City, or the City's departments, commissions or boards, which are not authorized by the City's Budget as approved and adopted by the City Council (65 ILCS 5/8-2-9.1 & 8-2-9.2);

WHEREAS, on April 19, 2010 the City enacted its Budget Ordinance No. 2780, which approved and adopted its Budget for the City's fiscal year commencing May 1, 2010 and ending April 30, 2011 ("Budget");

WHEREAS, since the adoption of the City's Budget, the City has determined that capital improvements are needed at the City's Miller-Fiege Home property ("Miller-Fiege Home") exceeding the total amount approved by the City Council pursuant to its passage of the City's Budget Ordinance No. 2780, which capital improvements include a new roof and sheathing, as well as tuck pointing of the property's chimneys and installation of wood siding on the back dormers;

WHEREAS, the amount of capital improvements needed at the Miller-Fiege Home was unknown at the time the City's Budget was approved and adopted by the City Council, and therefore was not fully included in the Budget;

WHEREAS, the City has ample funds in its Capital Development Fund, which is utility tax supported, to pay for the capital improvements needed at the Miller-Fiege Home;

WHEREAS, the Illinois Municipal Code allows and provides that by two-thirds (2/3) vote of the members of the City Council holding office the annual Budget of the City may be revised, provided the City has adequate funds to pay for any such Budget revisions (65 ILCS 5/8-2-9.6); and

WHEREAS, the City Council of the City has found and determined and does hereby declare that it is necessary and appropriate that the City's Budget be changed and amended to allow for the capital improvements of the Miller-Fiege Home and the funding of said capital improvements from the City's Capital Development Fund.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

**Section 1.** The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

**Section 2.** The annual Budget of the City of Columbia, Illinois for its fiscal year commencing on May 1, 2010 and ending on April 30, 2011, which was approved and authorized by its City Ordinance No. 2780, enacted April 19, 2010, is hereby changed and amended as follows:

- (A) General Fund – Budget Fund Category 001-00-49730 – Fiege Property Expense is hereby increased from it's original budgeted amount of \$6,200 to a revised budgeted amount of \$42,200; and
- (B) Capital Development Fund – an additional Budget Fund Category numbered 014-00-49701 and titled “Miller-Fiege Home Capital Improvements Transfer” is hereby added to the Budget in the amount of \$16,000.

**Section 3.** This ordinance shall be in full force and effect from and after its passage and publication in pamphlet form, as provided by law.

Alderman Roessler moved the adoption of the above and foregoing Ordinance; the motion was seconded by Alderman Oberfell, and the roll call vote was as follows:




