**ORDINANCE NO. 2903**

**AN ORDINANCE REAFFIRMING ORDINANCE NO. 1409  
ADOPTED ON DECEMBER 18, 1995 ACCEPTING AND  
APPROVING THE FINAL PLAT FOR THE "SITZES  
SUBDIVISION", A RESUBDIVISION OF TAX LOT 66 OF  
OUTLOTS, SECTION 16, TOWNSHIP 1 SOUTH, RANGE  
10 WEST OF THE THIRD PRINCIPAL MERIDIAN, CITY  
OF COLUMBIA, MONROE COUNTY, ILLINOIS.**

WHEREAS, the City of Columbia, Illinois (the "City) adopted Ordinance No. 1409 on December 18, 1995 accepting and approving the final plat for the "Sitzes Subdivision", a Resubdivision of Tax Lot 66 of Outlots, Section 16, Township 1 South, Range 10 West of the Third Principal Meridian, City of Columbia, Monroe County, Illinois; and

WHEREAS, sidewalk was to be installed on Whiteside Avenue in said subdivision; and

WHEREAS, said sidewalk was to be constructed and installed per a cooperation agreement authorized and approved by Ordinance No. 1408 passed and approved by the City Council on December 18, 1995; and

WHEREAS, said cooperation agreement was not executed, said sidewalk was not constructed and installed and said final plat was not signed and recorded; and

WHEREAS, said sidewalk has subsequently been constructed and installed and Ordinance No. 1408 has therefore been repealed; and

WHEREAS, said final plat can be signed and recorded;

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

**Section 1.** The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

**Section 2.** The City Council hereby reaffirms the adoption of Ordinance No. 1409 adopted on December 18, 1995 accepting and approving the final plat for

"Sitzes Subdivision", a Resubdivision of Tax Lot 66 of Outlots, Section 16, Township 1 South, Range 10 West of the Third Principal Meridian, City of Columbia, Monroe County, Illinois.

**Section 3.** The Mayor and City Clerk are hereby authorized to sign the final plat accepted and approved by this ordinance.

**Section 4.** This Ordinance shall take effect upon its passage and approval as provided by law.

Alderman Reis moved the adoption of the above and foregoing Ordinance; the motion was seconded by Alderman Roessler and the roll call vote was as follows:

NAYS: None.


