WHEREAS, in the City of Columbia, Illinois ("City") the City Administrator is the City's Budget Officer ("Budget Officer"), and by State law it is the responsibility of the Budget Officer to complete the City's annual Budget and have it approved and adopted by the City Council and thereafter, among other things, it is the responsibility of the Budget Officer to establish and maintain procedures to insure that no expenditures are made by the City, or the City's departments, commissions or boards, which are not authorized by the City's Budget as approved and adopted by the City Council (65 ILCS 5/8-2-9.1 & 8-2-9.2);

WHEREAS, on April 18, 2011 the City enacted its Budget Ordinance No. 2864, which approved and adopted its Budget for the City's fiscal year commencing May 1, 2011 and ending April 30, 2012 ("Budget");

WHEREAS, since the adoption of the City's Budget, the City has received an invoice from the Illinois Department of Transportation ("IDOT") in the sum of \$55,970.71 for an installment payment of the City's share (\$132,624.25) of the total cost of the Rueck Road Phase IV Project in the City (\$331,374.25), the sum of \$20,682.82 of the City's local interest participation in said project having been heretofore paid and \$27,985.36 is due on 11/15/12 and \$27,985.36 is due on 11/15/13; notwithstanding the Rueck Road Phase IV reconstruction project was completed, approved, accepted and Rueck Road was open to the public approximately three (3) years ago.

WHEREAS, said amount due IDOT on this project was unknown to the City Council at the time the City's Budget was approved and adopted by the City Council, and therefore was not fully included in the Budget;

WHEREAS, the City has received \$42,636 from the Motor Fuel Tax Administration FY 2012 Illinois Jobs Now Capital Bill Program for Municipalities, which distribution was unknown at the time the City's Budget was approved and adopted by the City Council and therefore not included in the Budget;

WHEREAS, THE City has ample other funds in its Motor Fuel Tax Fund, not already obligated, in addition to the \$42,636 to pay the invoice due from IDOT for the Rueck Road Phase IV Reconstruction Project;

WHEREAS, the Illinois Municipal Code allows and provides that by two-thirds (2/3) vote of the members of the City Council holding office the annual Budget of the City may be revised, provided the City has adequate funds to pay for any such Budget revisions (65 ILCS 5/8-2-9.6); and

WHEREAS, the City Council of the City has found and determined and does hereby declare that it is necessary and appropriate that the City's Budget be changed and amended to add thereto the sum of \$55,970.71 to be paid to IDOT for the first installment payment of the City's remaining local interest participation in the Rueck Road Phase IV Reconstruction project from funds so specified in the City's Motor Fuel Tax Fund.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

**Section 1.** The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

**Section 2.** The annual Budget of the City of Columbia, Illinois for its fiscal year commencing on May 1, 2011 and ending on April 30, 2012, which was approved and authorized by its City Ordinance No. 2864, enacted April 18, 2011, is hereby changed and amended as follows:

(A) Motor Fuel Tax Fund – Budget Fund Category 012-00-49143 – Rueck Road Construction Phase IV is hereby increased from it's original budgeted amount of \$0.00 to a revised budgeted amount of \$55,970.71; and

**Section 3.** This ordinance shall be in full force and effect from and after its passage and publication in pamphlet form, as provided by law.

Alderman Roessler moved the adoption of the above and foregoing Ordinance; the motion was seconded by Alderman Huch, and the roll call vote was as follows:






