**AN ORDINANCE TO AUTHORIZE THE MAYOR OF THE CITY OF COLUMBIA, ILLINOIS TO EXECUTE A COOPERATION AGREEMENT WITH THE COLUMBIA HISTORICAL SOCIETY REGARDING DISPLAY OF HISTORICAL ITEMS AND ARTIFACTS**

WHEREAS, the Columbia Historical Society (hereinafter "Society") now intends and desires to transfer and convey the former Schneider's Farm property to the City of Columbia (hereinafter "City") so that the City will own the property and improvements located thereon and will be able to protect, maintain, restore and preserve the site for posterity; and

WHEREAS, the Society and the City have mutually reached Agreement on conditions under which the ownership of the Schneider's Farm property may be transferred; and

WHEREAS, certain items and artifacts of historic value are not included in the aforementioned Agreement concerning real property; and

WHEREAS, the Society and the City mutually desire to display these historical items and artifacts for public viewing and enjoyment.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

**Section 1.** The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

**Section 2.** The Mayor is hereby authorized to sign the attached Agreement; and, the City Clerk is hereby authorized and directed to attest the same and affix thereto the corporate seal of the City, in as many counter parts as the Mayor shall decide.

**Section 3.** This Ordinance shall be in full force and effect from and after its passage, as provided by law.





**COOPERATION AGREEMENT BETWEEN THE CITY OF  
COLUMBIA, ILLINOIS & THE COLUMBIA HISTORICAL  
SOCIETY REGARDING DISPLAY OF HISTORIC ITEMS  
AND ARTIFACTS**

THIS AGREEMENT is made and entered into between the CITY OF COLUMBIA, ILLINOIS, a municipal corporation and body both corporate and politic of the State of Illinois, the Party of the First Part, (the "City") and the COLUMBIA HISTORICAL SOCIETY, a not-for-profit corporation created and existing under and by virtue of the laws of the State of Illinois, the Party of the Second Part, (the "Society"), this 18th day of June, 2012, WITNESSETH:

WHEREAS, the Society is known to be the community's foremost collector of historical items and artifacts; and

WHEREAS, the Society wishes to display these historical items and artifacts for public viewing and enjoyment; and

WHEREAS, the City hopes to facilitate the Society's desire to offer these historical items and artifacts for public enjoyment; and

WHEREAS, the City has suitable facilities in which to display items and artifacts of historical significance.

NOW, THEREFORE, in consideration of the premises and for other good and valuable consideration the receipt and sufficiency of which is hereby acknowledged by the parties hereto, the parties hereto hereby stipulate and agree as follows:

**Section 1.** The City agrees that it does not have any ownership interest or right to the historical items and artifacts owned, possessed, or displayed by the Society;

**Section 2.** The City will maintain insurance coverage equal to the value estimated by the Society for each of the historical items and artifacts displayed or stored at City facilities;

**Section 3.** The Society agrees to catalog (photograph and describe) all historical items and artifacts displayed or stored at City facilities, and to include an estimated monetary value for each said historical item or artifact;

**Section 4.** The Society agrees to update said catalog as necessary, but no less often than annually, and provide a copy of same to the City;

**Section 5.** This Agreement shall extend to and be obligatory upon the parties and their respective heirs, devisees, legatees, personal representatives, successors, and assigns;

**Section 6.** This Agreement shall continue in effect for a period of twenty (20) years from the date it is entered into and shall be renewable for additional periods of twenty (20) years, or for such lesser periods as may be agreed upon between the parties.

IN WITNESS WHEREOF the parties hereto have made, executed and delivered the above and foregoing Agreement for the uses and purposes set forth above, by their undersigned legal representatives, to take effect as hereinabove is made and provided in this Agreement.
