**AN ORDINANCE AMENDING THE DEFINITION OF KENNEL IN  
SECTION 17.04.030 (DEFINITIONS AND RULES OF CONSTRUCTION)  
OF TITLE 17 (ZONING) OF THE MUNICIPAL CODE OF THE CITY OF  
COLUMBIA, ILLINOIS.**

WHEREAS, the City Council of the City of Columbia, Illinois has determined it is necessary and appropriate and in the public interest to amend the definition of Kennel in Section 17.04.030 (Definitions and Rules of Construction) of Title 17 (Zoning) in the City of Columbia, Illinois.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

**Section 1.** The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

**Section 2.** Section 17.04.030 (Definitions and Rules of Construction) of Title 17 (Zoning) of the City of Columbia, Illinois Municipal Code is hereby amended by deleting the definition of Kennel from

“Kennel” means any structure or premises where three or more dogs over four months of age are kept.

and amending it to read

“Kennel” means any premise where dogs, cats or other small animals are boarded for compensation or are bred or raised on a commercial scale.

**Section 3.** All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**Section 4.** This ordinance shall be in full force and effect from and after its passage and publication in pamphlet form, as provided by law.

ABSENT: Aldermen Hutch and Piazza.




