WHEREAS, in the City of Columbia, Illinois ("City") the City Administrator is the City's Budget Officer ("Budget Officer"), and by State law it is the responsibility of the Budget Officer to complete the City's annual Budget and have it approved and adopted by the City Council and thereafter, among other things, it is the responsibility of the Budget Officer to establish and maintain procedures to insure that no expenditures are made by the City, or the City's departments, commissions or boards, which are not authorized by the City's Budget as approved and adopted by the City Council (65 ILCS 5/8-2-9.1 & 8-2-9.2);

WHEREAS, on April 16, 2012 the City enacted its Budget Ordinance No. 2948, which approved and adopted its Budget for the City's fiscal year commencing May 1, 2012 and ending April 30, 2013 ("Budget");

WHEREAS, the City Council has determined that it is in the City's best interests, and for the benefit and safety of the motoring public, to remove and replace the superstructure of the Valmeyer Road bridge at its crossing of Carr Creek ("Valmeyer Road Bridge Rehabilitation Project");

WHEREAS, it is necessary for the City to contract for the preliminary engineering and design work to allow for the completion of the Valmeyer Road Bridge Rehabilitation Project in a timely manner, and the appropriation of funds to pay for said preliminary engineering and design work is not contained in the City's current Budget;

WHEREAS, the payments for the preliminary engineering and design work for the Valmeyer Road Bridge Rehabilitation Project are to be made from the City's Tax Increment Financing District Fund ("TIF Fund"), and the TIF Fund contains excess (unbudgeted) cash available to pay for such preliminary engineering and design work;

WHEREAS, the Illinois Municipal Code allows and provides that by two-thirds (2/3) vote of the members of the City Council holding office the annual Budget of the City may be revised, provided the City has adequate funds to pay for any such Budget revisions (65 ILCS 5/8-2-9.6); and

WHEREAS, the City Council of the City has found and determined and does hereby declare that it is necessary and appropriate that the City's Budget be changed and amended to allow for the payment of the preliminary engineering and design work for the Valmeyer Road Bridge Rehabilitation Project from the City's TIF Fund.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. The recitals contained in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

Section 2. The annual Budget of the City of Columbia, Illinois for its fiscal year commencing on May 1, 2012 and ending on April 30, 2013, which was approved and authorized by its City Ordinance No. 2948, enacted April 16, 2012, is hereby changed and amended as follows:

Tax Increment Financing District Fund – an additional Budget Fund Category numbered 038-00-47650 and titled “Engineering & Design Valmeyer Road Bridge” is hereby added to the Budget in the amount of \$45,000.

Note: No other changes are necessary since the funds to be used to pay the engineering and design work added to the budget herein are currently contained in the TIF Fund as excess cash.

Section 3. This ordinance shall be in full force and effect from and after its passage and publication in pamphlet form, as provided by law.

Alderman Ebersohl moved the adoption of the above and foregoing Ordinance; the motion was seconded by Alderman Huch, and the roll call vote was as follows:
