**AN ORDINANCE TO AMEND ORDINANCE NO. 2968, WHICH PROVIDED FOR THE APPOINTMENT OF MEMBERS OF CERTAIN BOARDS, COMMISSIONS AND COMMITTEES OF THE CITY OF COLUMBIA, ILLINOIS FOR THE FISCAL YEAR OF THE CITY COMMENCING MAY 1, 2012 AND ENDING APRIL 30, 2013**

WHEREAS, the City Council of the City of Columbia, Illinois (hereinafter the "City") adopted Ordinance No. 2968 on August 6, 2012, and now finds it necessary to amend said ordinance to replace three members of the Heritage & Preservation Commission due to the resignation of individuals previously appointed.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Columbia, Illinois, as follows:

**Section 1.** Ordinance No. 2968, Section 10, is hereby amended by deleting the name "Lauren Nobbe" and dates "05/01/12 – 04/30/14" then adding the name "Suzanne Kutterer-Siburt" and dates "12/03/12 – 04/30/14" in their stead.

**Section 2.** Ordinance No. 2968, Section 10, is hereby further amended by deleting the name "Elizabeth Loy" and dates "05/01/12 – 04/30/14" then adding the name "Andrea Degenhart" and dates "12/03/12 – 04/30/14" in their stead.

**Section 3.** Ordinance No. 2968, Section 10, is hereby further amended by deleting the name "Herb Beckerle" and dates "05/01/11 – 04/30/13" then adding the name "Jennifer Gillum Beech" and dates "12/03/12 – 04/30/13" in their stead.

**Section 4.** All other appointments made by, and provisions contained in, said Ordinance No. 2968 not amended hereby, shall remain in full force and effect.

**Section 5.** This ordinance shall be in full force and effect, and the appointments made herein shall be effective as of the appointment dates shown hereon, from and after its passage as provided by law.

NAYS: None.


