AN ORDINANCE AMENDING SECTION 10.44.010 (PROHIBITED PARKING ON CERTAIN PUBLIC STREETS) OF TITLE 10 (VEHICLES AND TRAFFIC) OF THE MUNICIPAL CODE OF THE CITY OF COLUMBIA, ILLINOIS BY ADDING 250 FEET ALONG THE NORTH AND SOUTH SIDE OF BRADINGTON DRIVE WEST OF VETERANS PARKWAY.

WHEREAS, the City Council of the City of Columbia, Illinois has determined it is necessary and appropriate and in the public interest to amend Section 10.44.010 (Prohibited Parking on Certain Public Streets) of Title 10 (Vehicles and Traffic) in the City of Columbia, Illinois by adding prohibited parking along the north and south side for Bradington Drive from the southwesterly line of Veterans Parkway a distance of two hundred fifty (250) feet.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

Section 2. Section 10.44.010 (Prohibited Parking on Certain Public Streets) of Title 10 (Vehicles and Traffic) of the City of Columbia, Illinois Municipal Code is hereby amended by adding

77. Along the north and south side of Bradington Drive from the southwesterly line of Veterans Parkway a distance of two hundred fifty (250) feet.

Section 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 4. This ordinance shall be in full force and effect from and after its passage and publication in pamphlet form, as provided by law.


