II. STATED PURPOSE

Mayor Hutchinson stated the Executive Session was called to discuss collective negotiating matters between the public body and its employees or their representatives, or deliberations concerning salary schedules for one or more classes of employees.

1. Mayor Hutchinson turned the meeting over to City Administrator Al Hudzik and City Engineer Ron Williams to update the City Council on the Department of Public Works (DOPW) Mediation Session(s) relating to the 2009-2012 Collective Bargaining Contract.

Mr. Hudzik indicated that the Mediation Session held June 30th, 2010 in the City Hall Auditorium was attended by Federal Mediation & Conciliation Service Commissioner Max Aud, DOPW representatives Bill Coleman, Steve Thackrey and Bruce Shields and city representatives Mark Weisman, Ron Williams and Al Hudzik.

Mr. Hudzik noted that, at Mr. Aud's request, representatives of each party (Mr. Hudzik for the City of Columbia and Mr. Shields for the DOPW) described their current respective positions and offers.

Mr. Aud then twice met separately with each party. During the final meeting with the City representatives, Mr. Aud outlined the minimum terms the DOPW representatives felt the DOPW workers would be willing to accept and asked that those terms be relayed to the Council; Mr. Weisman, Mr. Hudzik and Mr. Williams then outlined for Mr. Aud what they felt the City's final offer would be (subject to Council approval).

After being updated on the Mediation Session(s) and informed of the minimum terms the DOPW employees might be willing to accept, a general discussion was held; it was the consensus of the Council and Mayor that Mr. Hudzik should send an e-mail to the DOPW representatives, Mr. Coleman, Mr. Thackrey and Mr. Shields, with a copy going to the Mediator, Mr. Aud, containing the Council's response (i.e., the terms described by the City representatives in the final

Mediation Session which they felt would be the City's final offer), and stating that it is the City's last, best and final offer.

III. ADJOURNMENT

There being no further business to be brought before the Council in Executive Session, Mayor Hutchinson asked for a motion to return to the Regular Session of the City Council at 8:51 P.M.




