**II. STATED PURPOSE**

A. Personnel - Update/discussion on collective bargaining negotiations and employee salaries

Mayor Hutchinson stated the Executive Session was called to discuss collective negotiating matters between the public body and its employees or their representatives, or deliberations concerning salary schedules for one or more classes of employees.

Mayor Hutchinson turned the discussion over to City Administrator Al Hudzik and City Engineer Ron Williams. Mr. Hudzik informed the Council that he and Mr. Williams recently met with labor attorney Mark Weisman and updated him on the current status of the negotiations with the DOPW, and to discuss the next steps to be taken. Mr. Hudzik indicated that Bill Coleman, the Steelworkers representative negotiating on behalf of the DOPW, had e-mailed him to let him know the DOPW was requesting mediation. Mr. Weisman concurred that mediation was the next logical step and Mr. Hudzik indicated that he will ask Mr. Coleman to arrange for the mediation hearing.

Mr. Hudzik suggested that Mr. Weisman attend the mediation session. He also indicated that Mr. Weisman suggested that the Council have something to offer in addition to what has already been proposed and then be ready to stand pat.

After some discussion, the consensus of the Council was to agree with the suggestions as presented.

There being no further business to be brought before the Council in Executive Session, Mayor Hutchinson asked for a motion to return to the Regular Session of the City Council at 8:06 P.M.




