**AN ORDINANCE AMENDING ORDINANCE NO. 3023
WHICH ESTABLISHED THE BUDGET OF THE CITY OF
COLUMBIA, ILLINOIS FOR ITS FISCAL YEAR
COMMENCING MAY 1, 2013 AND ENDING APRIL 30,
2014**

WHEREAS, in the City of Columbia, Illinois ("City") the City Administrator is the City's Budget Officer ("Budget Officer"), and by State law it is the responsibility of the Budget Officer to complete the City's annual Budget and have it approved and adopted by the City Council and thereafter, among other things, it is the responsibility of the Budget Officer to establish and maintain procedures to insure that no expenditures are made by the City, or the City's departments, commissions or boards, which are not authorized by the City's Budget as approved and adopted by the City Council (65 ILCS 5/8-2-9.1 & 8-2-9.2);

WHEREAS, on April 15, 2013 the City enacted its Budget Ordinance No. 3023, which approved and adopted its Budget for the City's fiscal year commencing May 1, 2013 and ending April 30, 2014 ("Budget");

WHEREAS, since the adoption of the City's Budget, the City has determined that a Mixing Zone Analysis is a necessary part of the City's Wastewater Discharge Permit Renewal Process, the cost of which was not included in the City's Budget Ordinance No. 3023;

WHEREAS, the need for the Mixing Zone Analysis was unknown at the time the City's Budget was approved and adopted by the City Council, and therefore was not included in the City's Budget;

WHEREAS, the City has ample funds in its Sewer Operations Fund to pay for the Mixing Zone Analysis;

WHEREAS, the Illinois Municipal Code allows and provides that by two-thirds (2/3) vote of the members of the City Council holding office the annual Budget of the City may be revised, provided the City has adequate funds to pay for any such Budget revisions (65 ILCS 5/8-2-9.6); and

WHEREAS, the City Council of the City has found and determined and does hereby declare that it is necessary and appropriate that the City's Budget be changed and amended to allow for the Mixing Zone Analysis to be performed in accordance with the requirements of the City's Wastewater Discharge Permit Renewal Process with the cost of said Mixing Zone Analysis to be paid from the City's Sewer Operations Fund.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

Section 2. The annual Budget of the City of Columbia, Illinois for its fiscal year commencing on May 1, 2013 and ending on April 30, 2014, which was approved and authorized by its City Ordinance No. 3023, enacted April 15, 2013, is hereby changed and amended as follows:

Sewer Operations Fund – an additional Budget Fund Category numbered 09-00-47350 and titled “Mixing Zone Analysis” is hereby added to the Budget in the amount of \$38,000.

Note: No other changes are necessary since the funds to be used to pay the Mixing Zone Analysis costs, as added to the City’s Budget hereby, are currently contained in the Sewer Operations Fund as excess cash.

Section 3. This ordinance shall be in full force and effect from and after its passage and publication in pamphlet form, as provided by law.

Alderman Roessler moved the adoption of the above and foregoing Ordinance; the motion was seconded by Alderman Holtkamp, and the roll call vote was as follows:






