**AN ORDINANCE TO AMEND ORDINANCE NO. 3056 WHICH PROVIDED FOR THE APPOINTMENT OF MEMBERS OF CERTAIN BOARDS, COMMISSIONS AND COMMITTEES OF THE CITY OF COLUMBIA, ILLINOIS FOR THE FISCAL YEAR OF THE CITY COMMENCING MAY 1, 2013 AND ENDING APRIL 30, 2014**

WHEREAS, The City Council of the City of Columbia, Illinois adopted Ordinance No. 3056 on August 19, 2013, and now finds it necessary to amend said ordinance to (A) replace the previously appointed Coordinator of the Emergency Services Disaster Agency of the City; and (B) fill a vacancy on the City's Street Graphics Advisory Committee.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois as follows:

**Section 1.** Ordinance No. 3056, Section 5 (Emergency Services Disaster Agency), is hereby amended by deleting the words "Wes Mathany" and "Appointed 08/19/13", since Mr. Mathany decided against accepting said appointment (and did not serve in that position), and inserting the name "Wesley J. Hoeffken", who is appointed hereby to serve as the Coordinator of the Emergency Services Disaster Agency of the City of Columbia, Illinois, from the date of adoption of this ordinance thru the date his successor is appointed and is duly qualified.

**Section 2.** Ordinance No. 3056, Section 6 (Street Graphics Advisory Committee), is hereby amended by deleting the word "Vacant" and inserting the name "Elizabeth Kutterer-Sanchez" in its stead, which individual is appointed hereby to serve on the City's Street Graphics Advisory Committee from the date of adoption of this ordinance thru April 30, 2015.

**Section 3.** All other appointments made by, and provisions contained in, said Ordinance No. 3056 not amended hereby, shall remain in full force and effect.

**Section 4.** This ordinance shall be in full force and effect, and the appointments made herein shall be effective as of the date of the passage and approval of this ordinance and as provided by law.

Alderman Holtkamp moved the adoption of the above and foregoing Ordinance; the motion was seconded by Alderman Huch, and the roll call vote was as follows:
