**II. STATED PURPOSE**

Mayor Hutchinson stated the Executive Session was called to discuss Collective Bargaining/Employee Wages.

**A. Collective Bargaining/Employee Wages Discussion**

Mayor Hutchinson requested that City Administrator Al Hudzik brief the Council on an August 21<sup>st</sup> meeting with the representatives from the Columbia Telecommunicators and the Columbia Police and the August 23<sup>rd</sup> meeting with those representing the Department of Public Works (USW Local 9189).

Mr. Hudzik and Chief of Police and Ambulance Director Joe Edwards discussed counter-proposals presented by the Telecommunicators and the FOP, in response to prior proposals presented by the City. Mr. Hudzik and Chief Edwards covered, point by point, the original proposals from the City and the counter-proposals. Mr. Hudzik indicated that meetings would be held within a week with both groups to continue discussions of the negotiating items.

City Engineer Ron Williams joined Mr. Hudzik in briefing the Council on responses and counter-proposals emerging from the August 23<sup>rd</sup> meeting with the DOPW representatives. Mr. Hudzik and Mr. Williams covered each of the City's proposals and the DOPW responses to those proposals. Mr. Hudzik added that another meeting has been scheduled for further negotiations next week.

Aldermen in attendance participated in the discussions and all had the opportunity to comment and offer opinions.

**III. ADJOURNMENT**

There being no further business to be brought before the Council in Executive Session, Mayor Hutchinson asked for a motion to return to the Regular Session of the City Council at 8:19 P.M.


