AN ORDINANCE TO AMEND TITLE 18 OF THE CITY OF COLUMBIA, ILLINOIS MUNICIPAL CODE TO ENACT AND AMEND THE FEES AND CHARGES TO BE ASSESSED FOR PARK FACILITY RESERVATION IN THE CITY UNTIL SAID TITLE 18 OF THE CITY'S MUNICIPAL CODE IS AGAIN AMENDED BY ORDINANCE OF THE CITY ENACTED TO CHANGE SAID FEES AND CHARGES

WHEREAS, the City Council of the City of Columbia, Illinois ("City") has previously found, determined, and declared that it was necessary and appropriate for the City Council to amend TITLE 18 of the City's Municipal Code, entitled:

"FEES AND CHARGES TO BE ASSESSED FOR CITY SERVICES AND BUSINESS LICENCE FEES TO BE ASSESSED FOR THE CONDUCT AND OPERATION OF BUSINESSES, OCCUPATIONS, AND PROFESSIONS IN THE CITY"

to change some of the fees and charges the City will collect for its ensuing fiscal year, which commenced May 1, 2015 and will end April 30, 2016 and to continue in effect after the enactment of the ordinance until said TITLE 18 of the City's Municipal Code is again amended by enactment of a City Ordinance changing said City's fees and charges; and

WHEREAS, the City Council of the City of Columbia, Illinois now desires to amend TITLE 18 of the City's Municipal Code to include fees and charges to be assessed for park facility reservation in the City.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. That the preceding recitations in the upper part of this Ordinance are realleged, restated and adopted as paragraph one ("1") of this Ordinance.

Section 2. That Chapter 18.85 of the City Code shall be amended to read as follows:

"18.85 Park Facility Reservation


18.85.001 Bolm-Schuhkraft Park Pavilion Reservation

A. Class I (Centennial Pavilion 1 and Lions Pavilion 2)

Half-day Weekend & Holiday – City Residents	\$ 25.00
Non-Residents	100.00
Full-day Weekend & Holiday – City Residents	50.00
Non-Residents	200.00
Full-day Weekday – City Residents	25.00
Non-Residents	100.00


Section 3. This Ordinance shall be in full force and effect immediately upon passage as provided by law.
