II. STATED PURPOSE

Mayor Hutchinson stated the Executive Session was called to update and discuss pending litigation. Specifically, the Litigation to be discussed is: American Federation of State, County and Municipal Employees, Council 31 (Charging Party) and the City of Columbia (Respondent) Complaint for Hearing Case No. S-CA-13-118

City Administrator Al Hudzik led the discussion regarding the Case with the Mayor, City Attorney and Aldermen having the opportunity to discuss, ask questions or offer opinions.

Mr. Hudzik updated the Council on the March 12th Mediation Session pertaining to this Case. He outlined the proposals received from representatives of former employee Jason Sitzes and the City's response by its representatives (Mr. Hudzik, Labor Attorney Mark Weisman and Police Chief Joe Edwards).

Mr. Hudzik turned the discussion over to Mr. Weisman. Mr. Weisman discussed the city's options in handling the Case, including the possibility of binding arbitration, a hearing before an ILRB Administrative Law Judge with an appeals process available to either party.

After discussing the scenarios for handling the Case, it was Mr. Weisman's recommendation that the City seek Arbitration in settling the matter.

III. ADJOURNMENT

There being no further business to be brought before the Council in Executive Session, Mayor Hutchinson asked for a motion to adjourn the Executive Session.




