**AN ORDINANCE AMENDING SECTION 18.82 OF THE CITY OF COLUMBIA  
MUNICIPAL CODE TO ESTABLISH NON-RESIDENT FEES FOR COLUMBIA  
EMERGENCY MEDICAL SERVICES**

WHEREAS, the City of Columbia ("City"), Monroe and St. Clair Counties, Illinois is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, the City Council of the City of Columbia ("City Council") previously adopted Section 18.82 of the City of Columbia Municipal Code ("City Code"), establishing fees for the City of Columbia's Emergency Medical Services; and

WHEREAS, Section 18.82 of the City Code currently provides a single rate for emergency medical services provided to residents and non-residents of the City of Columbia or Monroe County; and

WHEREAS, the City now desires to amend Section 18.82 of the City Code to add a separate emergency medical service fee schedule for those determined to be "non-residents" of the City of Columbia or Monroe County.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

**Section 1.** That the preceding recitations in the upper part of this Ordinance are realleged, restated and adopted as paragraph one ("1") of this Ordinance.

**Section 2.** That Section 18.82 of the City Code shall be amended to read as follows:

18.82.011      Definitions.

For purposes of this Section 18.28, “**City Resident**” shall be defined as any person that is a resident of the City of Columbia or a resident of Monroe County.

“**Non-Resident**” shall be defined as any person that is neither a resident of the City of Columbia or Monroe County.”

**Section 3.** This Ordinance shall take full force and effect after passage and approval by the Corporate Authorities.




