

MINUTES OF THE REGULAR MEETING OF THE CITY COUNCIL OF THE CITY OF COLUMBIA, ILLINOIS HELD
MONDAY, MARCH 5, 2018 IN THE COUNCIL ROOM OF CITY HALL

I. Call To Order

Mayor Pro Tem Ebersohl called the City Council of Columbia, Illinois to order at 7:00 P.M. Upon roll call, the following were:

II. Delegations and Citizens' Comments

A. Route 3 Corridor Discussion

City Clerk Wes Hoeffken read a statement from Mayor Hutchinson expressing sadness over the tragic accident last week and stating the City will be working with the Illinois Department of Transportation (IDOT) once the final police report is issued for the accident.

Deputy Chief Donjon distributed traffic statistics from 2008 through 2017. Chief Paul defined his use of the term Route 3 Corridor as being that section of Route 3 from North Main south to the YMCA. Chief Paul then presented an explanation about how the lights along the Route 3 Corridor are synchronized and that a driver can hit all lights under green if they maintain the speed limit. Chief Paul then stated because of this, it is easier to patrol for speeders. Chief Paul also explained the parameters for determining if a driver has run a red light, including counting the time from when a car crosses the white stop line until it clears the intersection. Chief Paul added that patrolling the Route 3 Corridor has always been a priority of the Columbia Police Department and will continue to be, referencing several IDOT sponsored grants the City has received in the past that focused on traffic patrols along Route 3. Chief Paul then reviewed the traffic statistics from 2008 through 2017. Chief Paul also stated that while the controlled intersections are set to a pre-determined cycle, the loop is longer for north bound traffic in the mornings, and longer for south bound traffic in the evening as a way to handle rush hour traffic.

Chief Paul added there is also a variation in the loop for school traffic. Chief Paul concluded by explaining the program that controls the lights can also sense increased side street traffic volumes and adjust the loop accordingly.

Mayor Pro Tem Ebersohl inquired if there were any comments or questions from the Council. There were none. Mayor Pro Tem Ebersohl then inquired if there were any questions or comments from the public.

Ms. Tara Masidonski, with the Citizens Demanding Changes On Illinois Route 3 Columbia, Illinois, inquired if the counts were current. Chief Paul stated the counts were for 2017 but he does not have updated figures for traffic on the side streets. Ms. Masidonski then stated one of the most challenging traffic issues is making a left turn off of Veterans Parkway onto Route 3.

Alderman Roessler thanked Chief Paul for providing the information and stated he was not aware of the engineering and programming that was involved with all of the traffic lights along the Route 3 Corridor. Alderman Roessler added that aggressive driving will ultimately result in being stopped at one of the red lights. Chief Paul stated IDOT has been a good partner and even issued a press release after the accident indicating they are looking for input to address driving issues along Route 3.


