**AN ORDINANCE TO EMPLOY HOELSCHER ENGINEERING,
P.C. OF FAIRVIEW HEIGHTS, ILLINOIS TO RENDER
PROFESSIONAL SERVICES TO THE CITY OF COLUMBIA,
ILLINOIS IN CONNECTION WITH THE CREEKSIDER
SUBDIVISION PARK AND LAKE PROJECT.**

WHEREAS, the City Council of the City has further found and determined and does hereby declare that it is necessary and appropriate that the City employ Hoelscher Engineering, P.C. to provide professional services to the City for development of a park with a lake including parking and a walking trail adjacent to the Creekside subdivision on an approximate 17 acre tract formerly known as the Garbarino property;

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

Section 2. The City Council of the city does hereby authorize the employment of Hoelscher Engineering, P.C. to provide the professional services to the city with regard to the City's Creekside Subdivision Park and Lake project. The Mayor is hereby authorized and directed to execute and deliver to Hoelscher Engineering P.C., for and on behalf of the City, the "Preliminary Engineering Services Agreement" between the City of Columbia, Illinois and Hoelscher Engineering, P.C. for a lump sum not to exceed Thirty Two Thousand dollars (\$32,000) in the form attached hereto, which is hereby approved as to form, in as many counterparts as the Mayor shall determine and the City Clerk is hereby authorized and directed to attest the same and to affix thereto the corporate seal of the City.

Section 3. This ordinance shall be in full force and effect from and after its passage, as provided by law.
