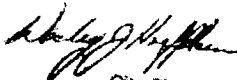

ORDINANCE NO. 2539

**AN ORDINANCE TO AUTHORIZE AN AGREEMENT TO
EMPLOY MCCONNELL & ASSOCIATES CORP. OF ST.
LOUIS, MISSOURI TO RESEAL BOLM-SCHUHKRAFT
TENNIS COURTS/BASKETBALL COURTS IN THE CITY
OF COLUMBIA, ILLINOIS**

WHEREAS, the City Council of the City of Columbia, Illinois (the "City") accepted the bid and awarded the contract to McConnell & Associates Corp. of St. Louis, Missouri (the "Contractor") at a regular meeting of the City Council held April 2, 2007 to reseal Bolm-Schuhkraft Tennis Courts/Basketball Courts in the City for a total price or sum of Twenty-Six Thousand One Hundred Fifty One Dollars and No Cents (\$26,151.00);

WHEREAS, the Notice of Award was given to the Contractor by the City on March 26, 2007 and the Contractor has executed and delivered to the City an Agreement to employ the Contractor to provide the material and to do and perform the work involved and the Contractor has provided the City with the required performance bond, labor and material bond, and certificate of comprehensive liability insurance which names the City as an additional insured, all of which are in due and proper form; and,

WHEREAS, it is necessary and appropriate that the City make and enter into the Agreement to employ the Contractor to provide the materials and to do and perform the work involved for the resealing of the tennis courts/basketball courts project aforesaid.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

Section 2. The Mayor is hereby authorized and directed to make and enter into the Agreement dated March 26, 2007 to employ the Contractor to perform the resealing of the tennis courts/basketball courts work described above (which is more particularly described in the employment Agreement), in the form attached hereto, in at least three (3) counterparts; and, the City Clerk is hereby authorized and directed to attest the same and affix thereto the corporate seal of the City.

Section 3. The City Engineer, Ronald J. Williams, P.E., is directed to deliver to the Contractor the Contractor's copy of the Agreement and to proceed with the preconstruction conference, if any, and the performance of the work involved.

Section 4. This Ordinance shall be in full force and effect, from and after its passage, as provided by law.

Alderman Unnerstall moved the adoption of the above and foregoing Ordinance; the motion was seconded by Alderman Ebersohl, and the roll call vote was as follows:

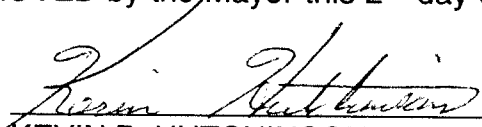
