AN ORDINANCE TO AMEND TITLE 18 OF THE CITY OF COLUMBIA, ILLINOIS MUNICIPAL CODE TO ADD CHAPTER 18.117 TO TITLE 18 TO BE ENTITLED "ARCHITECTURAL REVIEW BOARD FEES" TO BE CHARGED FOR THE REMAINDER OF THE CITY'S FISCAL YEAR ENDING APRIL 30, 2007 AND UNTIL SAID TITLE 18 OF THE CITY'S MUNICIPAL CODE IS AGAIN AMENDED BY ORDINANCE OF THE CITY ENACTED TO CHANGE SAID FEES AND CHARGES

WHEREAS, the City Council of the City of Columbia, Illinois (the "City") has found and determined and does hereby declare that it is necessary and appropriate for the City Council to amend TITLE 18 of the City's Municipal Code, entitled:

"FEES AND CHARGES TO BE ASSESSED FOR CITY SERVICES AND BUSINESS LICENSE FEES TO BE ASSESSED FOR THE CONDUCT AND OPERATION OF BUSINESSES, OCCUPATIONS, AND PROFESSIONS IN THE CITY"

to add a fee for Architectural Review Board review of building permit applications as described in Section 15.66.080 of the City Municipal Code that the City will collect for its current fiscal year, which will end on April 30, 2007 and to continue in effect after the enactment of this ordinance until said TITLE 18 of the City's Municipal Code is again amended by enactment of a City Ordinance to change said City's fees and charges.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. "TITLE 18" of the City of Columbia, Illinois Municipal Code, which is entitled: "FEES AND CHARGES TO BE ASSESSED FOR CITY SERVICES AND BUSINESS LICENSE FEES TO BE ASSESSED FOR THE CONDUCT AND OPERATION OF BUSINESSES, OCCUPATIONS, AND PROFESSIONS IN THE CITY" is hereby changed and amended to add CHAPTER 18.117, to be entitled "ARCHITECTURAL REVIEW BOARD FEES" to the chapter listing and for said chapter to read as follows:

18.117 Architectural Review Board Fees.

18.117 Review of Building Permit Application fee. Charge: \$250.00

Section 2. All resolutions or ordinances or parts of resolutions or ordinances in conflict herewith, to the extent of such conflict, are hereby changed and amended to be read and applied to be consistent with the provisions of this ordinance and preempted

thereby; and to the extent such conflict cannot be cured by amendment, to the extent of such conflict, are hereby repealed.

Section 3. This Ordinance shall be in full force and effect following publication of this Ordinance in pamphlet form, as provided by law.


