AN ORDINANCE AMENDING CHAPTER 18 OF THE CITY OF COLUMBIA, ILLINOIS MUNICIPAL CODE BY AMENDING SECTION 18.01.005 TO TITLE 18 ENTITLED "SEWER RATE EFFICIENCY DISCOUNT" TO BE IN EFFECT FOR THE REMAINDER OF THE CITY'S FISCAL YEAR ENDING APRIL 30, 2008 AND UNTIL SAID TITLE 18 OF THE CITY'S MUNICIPAL CODE IS AGAIN AMENDED BY ORDINANCE OF THE CITY ENACTED TO CHANGE SAID FEES AND CHARGES

WHEREAS, the City Council of the City of Columbia, Illinois has determined that it is necessary and appropriate and in the public interest to amend Chapter 18.01 (Sewer Rates) of Title 18, (Fees and Charges to be Assessed for the Conduct and Operation of Businesses, Occupations and Professions in the City) to allow for a 10% (ten per cent) discount in the sewer rate for certain water users in the City of Columbia, Illinois.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

**Section 1.** The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

**Section 2.** Chapter 18.01 (Sewer Rates) of Title 18, (Fees and Charges to be Assessed for the Conduct and Operation of Businesses, Occupations and Professions in the City) of the Municipal Code of the City is hereby amended to add the following to Section 18.01.005 (2) (Sewer Rate Efficiency Discount) as follows:

In lieu of or until an outflow meter system is installed, a 10% discount for the sanitary sewer service rates may be requested and will go into effect if approved by the City Council.

**Section 3.** All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**Section 4.** This ordinance shall be in full force and effect from and after its passage and publication in pamphlet form, as provided by law.




