ORDINANCE NO. 2618

**AN ORDINANCE TO AUTHORIZE AN AMENDMENT OF A  
CONTRACT BETWEEN PIERCE MANUFACTURING, INC.  
AND THE CITY OF COLUMBIA, ILLINOIS FOR THE  
PURCHASE OF A PLATFORM FIRE TRUCK**

WHEREAS, the City Council of the City of Columbia, Illinois (the "City") heretofore found and determined that it was necessary and appropriate that the City purchase a 100' platform truck for use by the Columbia Volunteer Fire Department;

WHEREAS, the platform truck will replace Truck 1912, a 1977 pumper truck, and Truck 1910, a 1986 rescue truck;

WHEREAS, the City Council of the City chose Pierce Manufacturing, Inc., of Appleton, Wisconsin as the appropriate company from which to purchase the platform truck and its apparatus and equipment;

WHEREAS, pursuant to City Ordinance No. 2615 of the City which authorized the purchase of the platform truck and approved the form of the agreement for the purchase, enacted December 3, 2007, the City made and entered into a contract with Pierce Manufacturing, Inc. to purchase the platform truck and appurtenant apparatus and equipment for Nine Hundred Twenty-Four Thousand Seven Hundred Dollars (\$924,700.00);

WHEREAS, since making and entering into said contract, the City has determined that it is necessary and appropriate that the contract be amended to made additions, changes or deletions to the contract that will increase the purchase price by Thirteen Thousand Five Hundred Ninety-One Dollars Ninety-One Cents (\$13,591.91) to Nine Hundred Thirty Eight Thousand Two Hundred Ninety-One Dollars and Ninety-One Cents (\$938,291.91) which additional cost has already been included in the City Fire Department budget; and,

WHEREAS, it is necessary and appropriate that this Ordinance be enacted for the purpose of authorizing the amendment aforesaid to the contract to purchase the platform truck and appurtenant apparatus and equipment.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

**Section 1.** The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

**Section 2.** The Mayor is hereby authorized and directed to make and enter into the "Change Order Form" pertaining to the contract for the purchase of the platform

truck and appurtenant apparatus and equipment from Pierce Manufacturing, Inc., in the form attached hereto, which is hereby approved as to form, and in as many counterparts as the Mayor shall determine; and, the City Clerk is hereby authorized and directed to attest the same and affix thereto the corporate seal of the City.

**Section 3.** This Ordinance shall be in full force and effect from and after its passage by the City Council and approval by the Mayor, as provided by law.

Alderman Ebersohl moved the adoption of the above and foregoing Ordinance; the motion was seconded by Alderman Stumpf, and the roll call vote was as follows:
