AN ORDINANCE TO AMEND ORDINANCE NO. 2300 LIMITING
PARKING OF VEHICLES ON THE PUBLIC STREETS IN THE
COLUMBIA LAKES SUBDIVISIONS IN THE CITY OF COLUMBIA,
ILLINOIS

WHEREAS, on November 1, 2004, the City Council of the City of Columbia, Illinois, passed Ordinance No. 2300 which limited parking of vehicles on the public streets in the Columbia Lakes Subdivisions on the City of Columbia, Illinois, and

WHEREAS, Ordinance No. 2300 amended Section 10.44.010 (No Parking Places) of Chapter 10.44 (PARKING PROHIBITED ON SPECIFIED STREETS) of Title 10 (VEHICLES AND TRAFFIC) of the City of Columbia, Illinois Municipal Code by adding the names of all streets on which parking is to be limited, and

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

Section 2. Section 10.44.010 (No Parking Places) of Chapter 10.44 (PARKING PROHIBITED ON SPECIFIED STREETS) of Title 10 (VEHICLES AND TRAFFIC) of the City of Columbia, Illinois Municipal Code (the introductory paragraph of which states: "At any time it is unlawful to permit any vehicle to park in any of the following places, except when necessary to avoid conflict with other traffic or compliance with the directions of a policeman or traffic control device") is hereby amended to add thereto subparagraph 74, to read as follows:

74. On the east side of Lake Side Drive from Micah's Way to Lake Shore Drive;

Section 4. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 5. This ordinance shall be in full force and effect from and after its passage and publication in pamphlet form, as provided by law.

Alderman Ebersohl moved the adoption of the above and foregoing Ordinance; the motion was seconded by Alderman Oberkfell, and the roll call vote was as follows:




