**AN ORDINANCE TO AMEND ORDINANCE NO. 2657 WHICH PROVIDED FOR THE APPOINTMENT OF MEMBERS OF CERTAIN BOARDS AND COMMISSIONS OF THE CITY OF COLUMBIA, ILLINOIS FOR THE FISCAL YEAR OF THE CITY COMMENCING MAY 1, 2008 AND ENDING APRIL 30, 2009**

WHEREAS, The City Council of the City of Columbia, Illinois adopted Ordinance No. 2657 on June 2, 2008, and now finds it necessary to amend said ordinance to fill vacancies on the Columbia Heritage and Preservation Commission by appointing new members.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois as follows:

**Section 1.** Ordinance No. 2657, Section 10, Columbia Heritage and Preservation Commission, is hereby amended by deleting the words, "Kathryn Campbell – 5/01/07 – 4/30/09" and adding the words, "Chris Brown – 7/07/08 – 4/30/09" in its stead; by deleting the words, "VACANT – 5/01/07 – 4/30/09" and adding the words, "Vern Ritter – 7/07/08 – 4/30/09" in its stead; and, by deleting the words, "VACANT – 5/01/08 – 4/30/10" and adding the words, "Charles Todd – 7/07/08 – 4/30/10" in its stead.

**Section 2.** The following people are hereby appointed to serve as members of the Columbia Heritage and Preservation Commission, for the following terms, to serve without compensation, to wit:

Chris Brown	7/07/08 – 4/30/09
Vern Ritter	7/07/08 – 4/30/09
Charles Todd	7/07/08 – 4/30/10

**Section 3.** All ordinances, resolutions, or orders in conflict herewith, to the extent of such conflict, are hereby repealed.

Alderman Hejna moved the adoption of the above and foregoing Ordinance; the motion was seconded by Alderman Unnerstall, and the roll call vote was as follows:


