AN ORDINANCE ADOPTING THE 2008 MONROE COUNTY
EMERGENCY OPERATION PLAN AND HAZARDOUS
MITIGATION IN ACCORDANCE WITH NATIONAL INCIDENT
MANAGEMENT SYSTEM AND HOMELAND SECURITY RULES

WHEREAS, in accordance with Homeland Security Rules covered under the National Incident Management System (NIMS), the City of Columbia must have an emergency operation plan and hazardous mitigation; and

WHEREAS, Monroe County, Illinois has taken several years to complete a plan that is in compliance with NIMS Regulations; and

WHEREAS, the City of Columbia Police Department recommends the adoption of the Monroe County Plan in its entirety;

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

Section 2. The City of Columbia, Illinois hereby adopts the 2008 Monroe County Emergency Operation Plan and Hazardous Mitigation in its entirety.

Section 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 4. This ordinance shall be in full force and effect from and after its passage and publication in pamphlet form, as provided by law.

Alderman Agne moved the adoption of the above and foregoing Ordinance; the motion was seconded by Alderman Row, and the roll call vote was as follows:


