AN ORDINANCE AMENDING CHAPTER 10.40.020 (TIME LIMIT PARKING ON SPECIFIC STREETS) OF TITLE 10 (VEHICLES AND TRAFFIC) OF THE MUNICIPAL CODE OF THE CITY ELIMINATING THE PARKING RESTRICTION OF FIFTEEN (15) MINUTES ALONG WEST LOCUST STREET FROM THE NORTHEASTERLY LINE OF NORTH RAPP AVENUE FOR A DISTANCE OF ONE HUNDRED SIXTY-FIVE (165) FEET IN THE CITY OF COLUMBIA, ILLINOIS.

WHEREAS, the City Council of the City of Columbia, Illinois has determined it is necessary and appropriate and in the public interest to amend Chapter 10.40.020 (Time Limit Parking on Specific Streets) of Title 10 (Vehicles and Traffic) regarding fifteen (15) minutes of parking along west Locust Street from the Northeasterly Line of North Rapp Avenue for a distance of one hundred sixty-five (165) feet in the City of Columbia, Illinois.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

Section 2. Section 10.40.020 (Time Limit Parking on Specific Streets) of Title 10 (Vehicles and Traffic) of the City of Columbia, Illinois Municipal Code stating: "It is unlawful, at any time, to park any vehicle for more than fifteen (15) minutes along the southeasterly side of West Locust Street from the northeasterly line of North Rapp Avenue for a distance of one hundred sixty-five (165) feet." is hereby deleted.

Section 4. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 5. This ordinance shall be in full force and effect from and after its passage and publication in pamphlet form, as provided by law.






