**I. CALL TO ORDER**

**I. CALL TO ORDER**

Chairman Mary Ellen Niemietz called the Parks, Playgrounds and Recreation Committee Meeting of the City Council of the City of Columbia, Illinois to order at 7:02 p.m.

Upon Roll Call, the following members were:

Present: Chairman Niemietz and Aldermen Ebersohl, Agne and Stumpf.

Absent: None.

Quorum Present.

Others Present: Mayor Hutchinson and Aldermen Row, Hejna, Oberfell and Roessler.

Administrative Staff Present: City Administrator Al Hudzik, Director of Community and Economic Development Paul Ellis and Accounting/Clerical Assistant Sandy Garmer.

Guest Present: Ed Settles, Superintendent of Schools of Columbia CUSD No. 4.

Chairman Niemietz stated the purpose of the meeting was to (1) receive a follow-up presentation from Columbia CUSD No. 4 Superintendent Ed Settles (see 02/08/10 Committee minutes); and (2) consider any other items to be discussed.

**II. COLUMBIA CUSD NO. 4 PRESENTATION**

Superintendent Settles thanked the Committee members for the opportunity to meet with them to again discuss the school district's lack of green space. He briefly touched upon some of the information presented at the Committee meeting on February 8, 2010, and again asked the Committee to consider selling a portion, or all, of the city's parkland located on the western edge of the Admiral Parkway Tax Increment Financing Project Area ("Admiral Parkway TIF Area Parkland"), as well as to use Bolm-Schuhkraft Memorial Park (but without the exclusive use of parts of the park) to assist the school district in addressing its lack of green space issue. A general discussion was then held in which all in attendance were given the opportunity to make comments and ask questions. Topics discussed included (a) if the school district would consider leasing a portion, or all, of the Admiral Parkway TIF Area Parkland, or possibly entering into a land exchange pertaining to that property; (b) the city's plans for the Admiral Parkway TIF Area Parkland; (c) the drainage issues pertaining to the Admiral Parkway TIF Area Parkland; and (d) the area of the Bolm-Schuhkraft Memorial Park the school district would like to

use, when it would be used, and the proposed uses. The discussion also included (i) a request that Mr. Settles supply the Committee with a detailed geographic plan and timetable on the school district's planned purchase/lease/exchange of the Admiral Parkway TIF Area Parkland, as well as the proposed usage of the Bolm-Schuhkraft Memorial Park; and (ii) the comment that the city's Play Commission is currently reviewing the parks reservation policy. Mr. Settles agreed to supply the requested information to the Committee/Council Members for their review and further consideration of the school district's requests.




#### **MOTION:**
